I am directed to convey the approval of appropriate authority for upgradation of your school from <u>Middle</u> to <u>Secondary</u> level without aid with effect from the academi session <u>2000-2001</u> subject to the fulfilment of the following terms and conditions within six months:

- 1. That the School shall abide by the provision of Delhi School Education Act. 1973 and Rules framed thereunder as well as the instructions issued from time to time.
- 2. That the School shall admit students without any discrimination of caste and creed.
- 3. That the School shall meet the additional liability of Seco ndary classes.
- 4. That the school shall purchase adequate Science Lab. equipments and apparatus as per the norms of C.B.S.E./ Education Department for Secondary classes.
- 5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
- 6. That adequate sports material shall be purchased and made available to the students.
- 7. That the School shall strictly abide by the provisions of Section 10(1) of the Delhi School Education Act/Rules 1973.

- 8. That the school shall not run any un-recognised classes of any non-educational activities within the School premises and all the recognised classes shall be run at any place at the above address only. Nursery classes be removed from the premises of the School immediately if any.
- That the School shall dispense with the services of unqualified and over-aged staff, if any immediately.
- 10. Fresh Health Certificate from MCD be obtained and produce to Education Officer for verification.
- 11. The Management of the school will obtain land from the DDA, if already not obtained, in the name of the Society through Directorate of Education, Delhi and shall construct a school building thereon for the school as per specification of the Department within the period of two years. That adequate and sufficient accommodation of 10 sq.ft. That adequate shall be provided for classrooms. The normal size of the classroom will 15 x 20 to the classroom w
- 12. That proper facilities for drinking water, toilet and first-aid be provided. Separate toilets for boys, girls and separate toilets for ladies and Gends staff be also provided.
- 13. That the Managing Committee of the School shall not increase/enhanced fee during the ensuing academic session without prior approval of the Director of Education which is a mandatory requirement under subsection (3) of section 17 of Delhi School Education Act and Rules, 1973.
- 14. That kie all the facilities prescribed under rules 50 & 51 of D.S.E.E 1973 shall be made available to the students.
- 18. That XI th class should not be added without the prior approval of the Director of Education.
- 16. That the Management of the School shall create a Reserve Fund equal to minimum three month salary of the staff in the joint name of the Director of Education and the manager of the School.
- 17. That the School shall comply with the norms of the C.B.S.E. for affiliation fees/examination purposes.
- 18. Inspite of the land being alloted by the D.D.A sanctioned building plan is not available.
- 19. Building completion Certificate has also not been obtained from the competent local body.
- 20. The nominees of the Director of Education on the Managing Committee have not given a favourable report.

- 21. The School has started class IX without getting it recognised.
- 22. Two members of the staff who are over-aged continued to be on the pay roll of the School.
- That the report about the falfilments of the above conditions shall be sent to the Education Officer 23. within six months.
